THEY LEARN HOW TO WORK IN SMALL GROUPS AND TO THINK CRITICALLY TO SOLVE PROBLEMS. PARENTS RECEIVE 215 HOURS OF LITERACY INSTRUCTION EACH YEAR IN CLASSES THAT MEET TWO NIGHTS EACH WEEK THROUGHOUT THE SCHOOL YEAR. TUTORING CLASSES FOR SCHOOL-AGE CHILDREN AND CHILD ACTIVITY CLASSES ARE OFFERED DURING THE CLASS TIMES. 105 PARENTS PARTICIPATE ANNUALLY. FOUR LEVELS OF CLASSES ARE AVAILABLE AND PRE-AND POST-EVALUATIONS ARE PROVIDED TO ENSURE THE PARENTS ARE IN THE APPROPRIATE CLASS FOR THEIR SKILL LEVEL.

PARENTS LEARN HOW TO TEACH THEIR PRESCHOOL CHILDREN LANGUAGE, MATH AND REASONING, AND SOCIAL AND EMOTIONAL SKILLS BEFORE THEY ENTER KINDERGARTEN. DURING THE CURRENT YEAR APPROXIMATELY 1,800 PARENTS AND CAREGIVERS PARTICIPATED IN THIS PROGRAM. ALL CLASSES ARE CONDUCTED IN ENGLISH AND SPANISH. ALL PARTICIPANTS RECEIVE A PARENT KIT THAT CONTAINS AGE APPROPRIATE TOYS, BOOKS, PUZZLES, AND TOOLS. IN THE CLASSES THE PARENTS LEARN HOW TO USE THE MATERIALS AT HOME.
